**Description:**

The work under this Contract consists of Mechanical Sweeping in Hernando and Pasco Counties.

The contract will be awarded at the Department's Advertised Project Cost amount of \$145,000.00; low bid will set the unit price.

The Department does not guarantee any maximum or minimum quantity, any range of quantities, or the exact quantities shown for each bid item. The Department's estimated quantities and the Contractor's bid price will be used to calculate a total bid amount. This total bid amount will then be used to determine the low bidder; however, actual payment under the awarded contract will be based on actual quantities completed. For this Contract in which specific sites are not identified at the time of letting, the Engineer will issue a Work Document. Work Documents will identify the location, description, amount of work to be accomplished, and the number of calendar days to complete the work.
